Thank you for your interest in writing for PRIM&R's blog, *Ampersand*.

PRIM&R is committed to promoting dialogue and debate on issues relevant to research ethics and oversight, and *Ampersand* is one of the mechanisms that we use to accomplish this. Through timely, thoughtful pieces on issues relevant to human subjects protections and animal care and use professionals, *Ampersand* generates conversation and provides resources for professionals in these fields.

Using *Ampersand*, PRIM&R seeks to foster a respectful online environment where diverse perspectives can be shared. Posts written by guest authors should reflect this goal and align with [PRIM&R's core values](#).

The submission of a post for inclusion on *Ampersand* indicates that you have read, understood, and agreed to be legally bound to the following:

- Through submission of a post, you grant PRIM&R a perpetual, royalty-free, non-exclusive license to use the content however we wish so long as we give you credit in the form of a byline.
- You grant PRIM&R permission to edit, modify, publish, distribute, and reproduce your post for any purpose, in any form, and on any media. You understand that PRIM&R staff may edit your post to adhere to PRIM&R's editorial style as well as for length.
- Content must be your own original work. When quoting others, sources should be cited appropriately. In the event of plagiarism/copyright infringement, you will be responsible for any and all damages. PRIM&R will not be held liable for your infringement of external publication rights.
- Content submitted to *Ampersand* may have been posted elsewhere previously. However, it is your responsibility, as the author, to ensure that submission to *Ampersand* is not in conflict with any publication rights already granted to other entities. Additionally, it is your responsibility to provide PRIM&R with a link to the site where the piece was originally posted.
- Unless otherwise agreed upon and documented in writing, you understand that there is no payment or compensation provided in exchange for publication of a post on *Ampersand*.
- PRIM&R reserves the right to remove and/or add any links to your post as it deems appropriate. Links to PRIM&R's website or other *Ampersand* posts should be included whenever relevant and appropriate. Please note that the inclusion of affiliate links is not permissible and that all external links on *Ampersand* will be included as no-follow links.
- PRIM&R is under no obligation at any time to post any submission and reserves the right to remove any post at any time after it has been posted without prior warning or explanation.
- You grant PRIM&R permission to use your name and likeness in order to promote your guest post through the organization's e-publications and on a variety of social media networks.
- You agree to let readers comment on your post. You also agree to review comments generated by your post and respond back (when appropriate) as yourself using the commenting feature on *Ampersand*.
- You agree to indemnify PRIM&R for all damages and expenses that may be incurred in connection with the material.
